President Martien called the meeting to order at 6:02 PM, Mountain time.

AWARDS PROCESSING

Awards Committee Chair Erin Leal shared information about the steps required to process show results and tabulate points for the various awards programs offered by USAWE, to demonstrate the complexity of the Awards process and answer any questions the Board might have regarding how awards are processed and why certain procedures are important to keep things running smoothly. Erin and her husband have devoted about 120 hours to date to automate the awards processes using a series of Excel formulas.

She covered the following:





- Receipt and Recording of Results this will walk the board through how we receive our results from show managers, where and how this is recorded, and when results are cleared to be posted
- Inclusion of Results into the Database this will provide the board with an overview of the database and member-sort process, and how we go from show-specific results to our historic records
- 3) From Database to Leaderboards this will give the board an idea of the processing required to take results and turn them into leaderboards, including the different parts of the organization the leaderboards need to reference
- 4) From Database to Medals this will give insight into the Medal process, including the Medal Update Program and our plans to feature Medal Recipients
- 5) From Database to Breed Awards this will give a preview of the Breed Awards we currently have, and how we hope to feature those breeds and their winners
- 6) Common Problems like any system, there are issues and bumps in the road. We are working with Competitions and Membership to solve several of these, but they include result inaccuracy, "all-Open" shows, and inconsistency in reporting.

The Awards Committee would like to get the Breed Awards publicized on social media but needs some assistance with this.

Numerous members of the Board commended Erin for her excellent work on the Awards tracking as well as the quality of her presentation to the Board.

She also brought to the Board a proposal that the judges' average score created by ANY double-judged show, regionals or otherwise, be included only once in a rider's Lifetime Medal calculations. Where shows are double-judged between judges of two different ranks, riders will be offered the benefit of the higher judge's rank.

RATIONALE for Proposal: This allows riders to still be incentivized within their particular year's leaderboards, without sacrificing the longevity and consistency of the medal program, and maintains consistent bookkeeping between our various awards reporting systems.

As most of our historic records do not note whether shows were split judged, double judged, or if split who judged what classes each did when there are multiple judges listed, riders have been given the benefit of the higher judge's rank in the historical scores. Given that the average does help to limit the potential for an unearned score, we believe the consistency and benefit to riders by offering the higher judge's rank towards their score is the most equitable option.

She also brought a proposal to the Board related to Lifetime Medals Calculations.





As Chair of the Awards Committee, Erin Leal made a motion to:

Motion: Judges' average score created by ANY double-judged show, regionals or otherwise, will be included only once in a rider's Lifetime Medal calculations. Where shows are double-judged between judges of two different ranks, riders will be offered the benefit of the higher judge's rank.

Motion was seconded by Kimberley Hillyer, R6 Director.
