2) Zone Proposal, Budget and Championship Evaluation Committee (CEC) Evaluation

Three 2022 Zone Championship Proposals were submitted by 12/15/21; one from Central Zone and two from Western Zone; Eastern Zone is pending securing a location.

Each proposal was reviewed by the Competitions Committee via a 2 hr zoom meeting on 12/18/21 (see proposal review with additional questions enclosed), missing information requested during CEC review. Additional comments captured during each CEC proposal(s) review held via a 2 hr zoom meeting with proposal submitter(s).

Central Zone - submitted by Karen Boso (IL) and Linda Frazier (KS) - CEC unanimously approved and recommended 12/20/21 by Chris Stanko (R3), Kiki Pantaze (R4), Becky Sherven (R5) and Jeanne Bond (CC) - most complete proposal submitted overall, RDs knowledgeable about their membership, competition and qualified rider base, realistic conservative budget, championship and rated show includes all (4) trials, affordable entry fees, proposal encouraged rider participation with personalized invites, rider referrals and encouraged rider participation in the other zone shows.

Ranked 2nd - Wine Country Classic submitted by Amanda Latta- Portillo - CEC unanimously approved and ranked 2nd choice on 12/22/21 by Heather Humelbaugh (R1), Robin Bond (R2) and Kris Blacklock (CC); Wine Country Classic CEC review also included Julie Alonzo (Show Manager), Chris Wilson (Facility Manager), Ashlyn Dorsey (Secretary / Sponsorship & Vendor Coordinator), Cheryl Croasmun (WCC Show Organizer) - initial proposal missed including cattle trial (during CEC review, WCC indicated will consider adding cattle trial based on a social media poll if proposal is approved), missed detailed income/expense budget (provided after CC requested); high entry fees, especially if cattle trial is held; show held in conjunction with multidiscipled show that includes Dressage, Ranch Riding, Halter and Rail classes; exceptional venue; time of year shouldn't incur travel barriers
