The Eastern Zone Championship proposal looks awesome, it's very well done; however, the Competitions Committee did not follow USA Policies and Procedures **2.4.3 Zone Championship Show Requirements and License Approval** "A Championship Evaluation Committee is designated for each zone; each committee is comprised of the Regional Directors within the zone and a representative of the Competitions committee who does not reside in the zone. The Championship Evaluation Committee will assess all proposals received."

The email from the Championship Committee does not indicate the Eastern Zone Championship Evaluation Committee reviewed, evaluated or sent the proposal for BOD review and the **Championship Evaluation Form** (available on the Competitions > Competitions Resources > <u>Request for Proposals – Zone Championships</u>) is also missing.

The Competition Committee needs to ensure they are following the USAWE Bylaws, Policies and Procedures, and in this instance, all zone proposals meet all the requirements before asking for BOD review/approval. Before the BOD can review and decide this proposal, it needs to be evaluated by the Zone Championship Evaluation Committee, meet all requirements and make sure all T's are crossed and I's are dotted.

I am sure this will pass, it needs to be done correctly; we need to follow in the P/P. Our meeting on February 8th has the potential to be 3 hours long (we already cut the Committee and Director updates to ensure all submitted topics could be discussed/decided). I really would rather not add anything else to the agenda. The Competitions Committee needs to set up a meeting for the Championship Evaluation Committee to review, complete the *Championship Evaluation Committee – Proposal Review*, ensure the proposal's budget includes all of the items outlined in the *Zone Championship Budget*, then the proposal can be done reviewed by the BOD with an email vote. I understand urgency is of essence, but the Committee needs to follow the Bylaws, Policies and Procedures and the zone championship evaluation criteria. I've talked with Stephanie this morning and she is waiting to put a deposit on the facility. If at all possible can this please be completed by the morning.

Dear Chris and members of the Board,

The Competitions Committee reviewed the Procedures in the Policies and Procedures manual prior to sending our request to the Board last night.

The committee's actions in no way violate any Bylaws or Policies. We followed the published Procedures, taking into account the fact that the two Regional Directors within the eastern zone are both named in the bid from NEWE and thus would be required to recuse themselves from service on the Championship Evaluation Committee.

We are fortunate that the Competitions Committee includes a Regional Director as well as three representatives who do not reside within the zone. The Competitions Committee was able to field a Championship Evaluation Committee during our meeting last night, and that group used the criteria to verify that the bid meets all requirements (it does) and that all i's were dotted and t's crossed (they are).

The Policies and Procedures manual is a living document and subject to periodic review and revision. The primary purpose of having written procedures is to ensure that the volunteers donating their time to conduct business on behalf of the organization have guidelines to follow. The competitions committee will be submitting a revision to the Procedures used for selecting Zone Championships to reflect the reality that -- when a single bid is received and that bid meets all requirements -- the process can and should be streamlined. The committee (which is the group responsible for writing up the procedures used to complete tasks) discussed this at length last night. Committee members were unanimous in their support of making sure the process meets the needs of the organization. That need includes focusing on both quality and efficiency in the interest of making good decisions.

Given that (a) **only one bid was received** for the 2023 Eastern Zone Championship, (b) **that bid met all requirements** for a Zone Championship, (c) **the two regional directors** who might otherwise serve on a committee to evaluate bids received **were both named in the bid and** thus **ineligible to serve on an evaluation committee** without conflict of interest issues, (d) we are already many months past the original deadline for bids to have been received, (e) **it is in the best interest of our members** to offer a Zone Championship in all three zones, (f) NEWE needs confirmation that their bid has been accepted so they can secure a very nice facility at a very reasonable cost, and (g) you have explained that the agenda for the next Board meeting is already quite full, **the Competitions Committee respectfully requests that the Board address the following motion through unanimous consent in writing (via email) rather than waiting for a Board meeting**.
